Building/Volunteer

- There has been a suggestion that we try to solicit volunteers from Greensburg for neighbors helping on another. United Way has agreed to put out a bulletin of sorts for volunteers across the state to promote volunteerism
- SCKTRO is looking to promote an "Alternate Spring Break" to the big 12 schools here in KS for volunteers to come work during spring break
- Blitz Build pre-construction to begin towards the end of February, beginning of March, with the builds to be done in April. We currently have 2 families lined up for this project.

Financial

Casework

Case #13- requesting funding for siding and insulation (\$2000.00) and additional funding of approximately \$1,600.00 for other repairs that appear to be non-tornado related. United Way has agreed to fund \$2,000.00 towards the cost of siding and insulation.

Case #83-Needs help with final costs on their basement. They have a USDA loan, but after paying off original mortgage with insurance funds, and paying for new home, they are short approximately \$12,000.00. United Way has agreed to fund this.

Case #75-Needs help with final costs on their foundation. They have purchased a modular, and received loans for all that they can afford. They need approximately \$12,000.00 to complete foundation work. Catholic Social Service has agreed to fund the foundation work.

Case #88-In need of assistance to cover plumbing and electric costs-estimate given is \$2,786.35 which Catholic Social Service has agreed to fund.

Case #98- Needing assistance with plumbing and electrical costs-estimate given was \$4,000.00. Catholic Social Service agreed to fund this on the stipulation that an effort was made to have some volunteer labor to help lower the costs.

Case #116-Single mother in need of financial assistance to have foundation wall in basement repaired. House was purchased after tornado and inspector hired did not do a thorough inspection-Estimates have been obtained for repairs which run from \$8,300.00 to \$9,800.00-At this time, funding is declined until more info can be obtained about legalities-Barb to look into.

Case #154-Client in need of a vehicle to get back and forth to doctors appointments and such-Catholic Social Service has agreed to fund \$1,300.00 towards the purchase of vehicle, tags and insurance.

Case #108-In need of assistance with electrical work. The estimate given is for \$850.00-The home needs to be completely re-wired. James has reviewed case and feels that this is a job for a professional, not volunteers-Catholic Social Service has committed to fund project.

Cases 25, 75, 86, 100, 142, 147 - in need of storm shelters-United Way has agreed to pay for the cost of these which are \$2,350.00 each.
